# **OLD OR UNFINISHED BUSINESS:**

President Doug Pearce welcomed everyone to the meeting, Secretary Valee Miller called for the Roll Call.

President Doug Pearce asked for approval for the 11.6.24 Directors Meeting Mintues

Michelle Van Dyke made a motion to approve the 11.6.24 Directors Meeting Minutes, seconded by John Delmonte, Motion Passed.

# **NEW BUSINESS:**

#### **Tentative Show Schedule**

- President Doug Pearce stated at this time there will be no MCHA Cutting in Dillon, Montana due to the lack of venue.
  - Vice President Ashley Lee stated there is a possibility of having a MCHA Cutting in Vaughn, Montana the last weekend in June
  - Andi James continues to be the contact for the Big Piney, Wyoming show.
     She plans on keeping the schedule close to the same as 2024. Planning on 2
     Weekend Shows & 4 LAE Shows. Andi James would like to hire Judges & make all travel arrangements.
    - There was a board discussion about increasing the daily rate of Judges from the previous \$500 to the going rate of 2025.

- The NILE board has reached out to the MCHA board of directors to have an MCHA approved show with their show in October, this will be based on cattle availability.

  - o NCHA Days Show, Sheridan, Wyoming Triangle T Produced
  - o Utah Show, still deciding on which one
    - Michelle Van Dyke brought up discussion of having 2 shows approved on the west side of the state, and 2 shows in Wyoming for the east side of the state.
    - There was board discussion about having Miller's Horse Palace produce a show in October to be the MCHA Year End show instead of having it in the middle of September with their show.
  - Michelle Van Dyke made a motion that all in state shows be MCHA approved as well as two out of state shows. Kelly Fraser to second, motion passed.

## **2025 Approved Classes**

- President Doug Pearce lead discussion on keeping all the same approved classes from 2024.
  - Cindy Fraser made the motion to approve all classes from 2024, Mike Hoffman to second this. Motion passed.

#### **Year End Awards**

There was board discussion of attending 2 or 3 in state shows to qualify for year end awards. Discussion led to the agreement 3 in state shows would need to be attended to qualify for year end awards. Cindy Fraser made a motion for this, Michelle Van Dyke to second, motion was passed.

#### **MCHA Approval Fees**

- o As per rule 10
  - 0 10. MCHA approval fees are \$4.00 per horse entry per MCHA approved class LESS MCHA memberships collected. If total memberships collected by a producer are less than \$4.00 per horse entry per MCHA approved class, the show producer is responsible for paying the deficiency. If total memberships collected by a producer are greater than \$4.00 per horse entry per MCHA approved class, the show producer is not required to pay an approval fee. Reciprocal show approval agreements or other arrangements deemed to be in the financial interest of MCHA may also be approved by the Board of Directors. Any approval fees owed shall be sent to the MCHA Secretary-Treasurer along with the results of the show

within ten (10) days of the close of the show. The show secretary is responsible for submitting approval and results to the NCHA

 Kelly Fraser made a motion to void Rule 10 and require no approval fees for non MCHA shows. Cindy Fraser to second. Motion Passed

## **Operating Budget Items**

- 2024 P&L
  - Finalizing the 2024 P&L. Reaching out to past board members Peri Suenram & John Seymour as to what is still outstanding for Hat Certificates & Custom Chaps to close out the 2024 year.
- 2025 Budget
  - Michelle Van Dyke brought up discussion of lowering the Year End Awards budget from \$20,000 to \$15,000. There was a board discussion in which the board agreed with their contacts they could easily make this happen in 2025.
